Section 1: Attendance News

New national attendance regulation changes



Regular attendance at school is extremely important to children's achievement, wellbeing, and wider development. Increasing attendance and reducing absence is the Government's number one priority and from August 2024, new regulations for schools come into force(External link) in the Government's next stage of their attendance drive.

What is changing?

The forthcoming changes include:

- Every state school in England will now share their daily attendance registers across the education sector.
- **Expansion** of the attendance hubs programme.

- Parent fines for unauthorised absences will also be brought under a national framework to help tackle inconsistencies in their use. A fine to parents must be considered if a child misses 5 days of school for unauthorised absence. Alongside this, costs for fines will go up from £60 to £80 if paid within 21 days and from £120 to £160 if paid in 28 days which will ensure all parents are aware of when they might face a fine to ensure all councils are issuing fines appropriately.
- Key guidance setting out how schools and local authorities must take a 'support-first' approach to help pupils and their families to tackle barriers to attendance will be made statutory from August 2024.
- **New regulations** to modernise school attendance and admission registers (including updating attendance codes, rules on granting leaves of absence and on who can access registers) to improve the accuracy of attendance data to help schools and local authorities put better, more targeted support in place as early as possible. These regulations also come into force on 19th August 2024.

Penalty Notices Changes – The Law



From August 2024, Penalty Notice Fines for School Attendance are changing - The government is introducing a new National Framework for Penalty Notices.

- **NEW National Threshold** Penalty Notice Codes of Conduct must include the same thresholds nationally 10 sessions of unauthorised absence in a rolling period of 10 school weeks. Bristol City Council must publish our Penalty Notice Code of Conduct.
- NEW requirement for all schools to consider a Penalty Notice Where
 the Penalty Notice threshold is met, in each individual case, the school must
 consider if a Penalty Notice is appropriate and take into account any
 considerations under the Equality Act 2010.
- NEW Notice to Improve (replaces the penalty notice warning letter) Schools should issue a Notice to Improve (where considered appropriate) see below for more information.
- NEW Increased fine amounts 1. The first time a Penalty Notice is issued for a Term-Time Leave of Absence or irregular attendance, the amount will be:
 - £160 per parent, per child (if paid within 28 days) but reduced to: £80 per parent, per child if paid within 21 days.
 - 2. The second time a Penalty Notice is issued for a Term-Time Leave of Absence or irregular attendance to the same parent for the same child the amount within a 3-year rolling period the fine will be £160 per parent, per child (if paid within 28 days) There is no reduction in the amount.

- **NEW Penalty Notice cap** A maximum of two fines for the same parent and same child in a rolling three-year period. If a 3rd offence is committed, other alternative action should be taken instead, such as prosecution. Prosecution may result in fines of up to £2,500 per parent, per child and cases found guilty in a Magistrate's Court can show on a parent's future DBS certificate.
- UNCHANGED Penalty Notice fines are issued Per Parent, Per child. This means that fines are issued to each parent, for each child who is absent. For example: If 2 siblings (who live with both parents) are absent for a term-time holiday this will result in each parent receiving 2 separate fines.

Bristol City Council's revised Penalty Notice Code of Conduct Consultation – Have your say...

This consultation proposes to continue the administration of the Bristol City Council Penalty Notice process in line with the new national framework, and the government attendance regulation changes and

statutory attendance guidance. As a result of these national changes, we have fully revised our local code of conduct to support the business-as-usual operating model for issuing Penalty Notices for school absence in Bristol.

This consultation is primarily intended for schools, other education settings, and the police, as the consultation is about local operational changes to the issuing Penalty Notices for school absence that will impact these organisations. The national changes are outside of the scope of the consultation.

Attendance data analysis & targeted attendance interventions



As we near the end of the academic year, now is the perfect time to review your attendance data to look for patterns and trends and use it to inform next step interventions. Routines could include:

• Identifying and analysing pupils who had absences in the first week of this academic year in September 2023. Intervene to prevent and reduce the likelihood of the same pattern in September 2024. Research

shows that pupils who are absent in the first week of the academic year are much more likely to go on to be persistent or severe absentees.

- Identify and analyse pupils who had absences in the first week of any term and intervene to prevent and reduce the likelihood of a similar pattern repeating in the new academic year.
- Identify and analyse any pupils who may have met the new national penalty notice thresholds this academic year. Have support and challenge conversations with their parents to prevent and reduce the likelihood of needing to request a Penalty Notice under the new national framework next academic year.
- Investigate the current attendance patterns for transition cohorts. Benchmark
 their attendance into cohorts and where necessary begin to have targeted
 attendance support and challenge conversations with parents, initiate
 individual attendance action plans early.
- Getting familiar with the school level attendance reports that are now available from the DfE via View Your School's Education Data. This includes regional and national attendance benchmarking data for your school.

DfE daily attendance data collection - WONDE data - to become a mandatory requirement from September 2024



WONDE is the DfE's software provider partner. The DfE is collecting automatic daily attendance data from schools that agree to share their data. At least 127 Bristol schools have already signed up. We encourage all schools to do so, those that are already on board are reporting positive feedback. This will be

a mandatory requirement for all schools from 19th August 2024.

The benefits in getting daily attendance data:

- 1. gives schools, local authorities and academy trusts access to more up-to-date pupil-level attendance data
- 2. helps you meet the new expectations set out in <u>working together to improve</u> school attendance
- 3. will not add to your school's workload

<u>Improving School Attendance – Support for Senior Leaders in Schools and Settings – 1 free place per setting</u>

This course provides guidance and practical strategies to school senior leaders with an attendance remit to support improvements especially for vulnerable groups.

The first part of this course sets out the principles underpinning an effective whole school strategy for attendance and develop a sense of belonging. The second part of this course outlines actions that schools may consider taking to improve attendance for all pupils, pupils at risk of persistent absence and pupils who are persistently absent (PA).

During this training, Bristol Healthy Schools will be running a short session aimed to support schools with "making the school a safe place" and fostering the "right ethos" for improving attendance. The session will be specific to school attendance, with a focus on mental health and creating safe spaces, addressing the theme of belonging in education.

Targeting Support Meetings (TSMs) for attendance



- Throughout this academic year, officers from the Education Welfare Service have been reaching out to all schools across the city to offer and deliver attendance targeting support meetings.
- During the summer, we will be revising the targeting support meeting offer for next academic year.
- Next academic year we will continue to work in partnership with all schools to have regular (between 1-3 per academic year) conversations with schools, using their attendance data to identify pupils and cohorts at risk of poor attendance and agree targeted actions and access to services for those pupils.

EWS traded attendance support options



The EWS have a variety of attendance support options that you can buy - other independent attendance providers are also available

- Flexible support charged at our half/whole day rates £295/£510 general flexible attendance support. Good for short pieces of targeted input on a 1:1 basis across several CYP/families.
- EWS parent/pupil attendance assessment charged at £295 with the option of upgrading to full referral rate on conclusion a more in-depth piece of one-off direct work with the family. An EWO contacts parent(s) and arranges to carry out

an EWS assessment (Individual Assessment Profile) to explore the reasons for absence and if appropriate draws up an action plan with the parent(s)/carer(s) to resolve their child's attendance issues.

• EWS full casework referral charged at £855 per case – an in-depth piece of 1:1 direct work with the family over a number of weeks with the aim of improving attendance or instigating legal proceedings if there is evidence to do so. End to end case management included and it includes the above EWS parent/pupil attendance assessment and attendance action plan.

Elective Home Education (EHE)



We want to ensure a parental decision to Electively Home Educate their child is an **informed decision**.

Please **do not persuade or encourage** parents to consider EHE as an option as this could be perceived as coercion and off-rolling.

However, if a parent raises it, please do signpost

them to impartial information that outlines what EHE entails.

EHE should not be used as a way to avoid suspensions, permanent exclusion or to avoid attendance legal interventions.

Please ensure any parents considering EHE are made aware of the LA EHE guidance Home education - bristol.gov.uk

An EHE Quick Guide and a Briefing Note are available on the Attendance Toolkit.

Children's vaccinations



Childhood infections like measles and whooping cough are rising, with outbreaks across the country. Such infections can have a huge impact on your child's life. They can miss out on learning time because they are unwell, be hospitalised, and even experience life-long complications and disability. If your child isn't vaccinated, they're not protected.

It is important for you to take up the offer of the NHS' free childhood immunisation programme as soon as you are offered it to ensure your child has the best protection. However, if you or your child have missed a vaccine, it is

never too late to check if you can catch up. You can check your child's Red Book to see if they have missed any vaccines or check with their GP if you are unsure. The school aged immunisation service (SAIS) is available for all children of school age, irrespective of their education setting. Your child's GP surgery or the Local Authority Public Health teams will be able to provide contact details of your local SAIS.
